## Parish Profile

### Biddestone and Slaughterford

On-going projects in the parish include preparing a village plan, now nearing completion. This has involved the formation of focus groups and a survey of all households. Planting around the edges of the pond will be undertaken shortly, the aim being to increase biodiversity through increased choice of habitats and protection from ducks! The war memorial should be renovated during the coming summer. A new seat has recently been placed on The Green.

We are also assuming responsibility for the public toilets, which should shortly be reopened.



Within Biddestone speeding traffic is a major problem. The Council agreed, with other local councils, to contribute to the cost of flashing warning signs at the junction with the A420. We are very concerned regarding the state of the road network in the parish, especially in the Slaughterford area. This is not helped by unsuitable vehicles being directed by satnav into narrow country lanes. **Tim Smith**

**Update on Chippenham Area Community Health Services**

15 representatives of local organisations joined the HASC group at their meeting on 2nd April 2008 when Tony Barron, Chair and Alison Knowles, director of Corporate Affairs and Communications at Wiltshire NHS Primary Care Trust (PCT) gave an update on community health services in our area.

The move to looking after people in their homes rather than spending time in hospital is going well. The Neighbourhood Team, which is made up of nurses, physiotherapists and occupational therapists and provides care in people's homes, is getting established, and by Summer 2008 will be providing a 24/7 service. The introduction of this service means that Health and Social Services are starting to work together to provide a seamless service.

Although beds will be closing at Chippenham Community Hospital (date for this to be decided at the PCT Board Meeting in May) the future of the Hospital is secure. At Chippenham Hospital there will be the stroke unit, inpatient unit, maternity unit, minor injury unit, outpatients, ambulatory care – therapies, diagnostics (x ray etc) – fixed and mobile, the Neighbourhood Team is based there and the mental health team. A rebuild is promised for 2010/11.

The PCT is particularly concerned about end of life care as 70% of people when asked, said they would like to die at home, but at the moment 70% of people die in hospital, so the PCT will be looking at ways of providing services which will enable this situation to be reversed.

Plenty of time was allowed for those attending to ask questions, and so the meeting was most helpful and informative.

The HASC group will continue to monitor the provision of health services in the Chippenham area.

**Hospital Discharge**

The HASC group has had discussions with Wiltshire NHS Primary Care Trust (PCT) about our concern for people who are discharged from acute hospitals and find that arrangements have not been made for their care when they get home. The PCT has been making efforts to improve discharge arrangements and although we think there has been some improvement we are still hearing about poor discharges. The Group thought it would help patients if a PCT PALS information leaflet was given to all patients upon discharge, and this has been taken up by the PCT.

PERFORUM – the association of arts groups in the Chippenham area - has made great progress since the last Newsletter.

Readers may recall that Area 3 of the North Wilts District Council had made a magnificent grant of £8,000

towards PERFORUM'S Neeld Hall stage enhancement project (but dependent on matched funds). Chippenham Borough Lands Charity had generously granted £2,000, and this allowed the first visible progress – 6 new permanent lanterns in the Neeld Hall.

Now PERFORUM'S members have stepped forward themselves, with generous donations totalling nearly £5,000. This means we are now getting close to matching and therefore releasing the District Council grant, and going on to provide all the improvements planned for the Neeld Hall.

We now have sufficient funds for a lower-and-raise stagecloth track (whereby a scene change is achieved by drawing a stagecloth quickly across the stage). Tendering is complete and we are ready to go ahead.

The full scheme will include a second stagecloth track system, improved lighting and sound equipment, a cyclorama, modular staging, and a lightweight scaffold tower. The work is co-ordinated through the Neeld Hall Working Party with the Town Council, who are going ahead with improving the stage surface, which has become uneven with time and wear.

PERFORUM groups are also working together to publicise events. We always struggle to spread the word about our exhibitions, concerts, shows etc, and we rely on income from audiences, so we are now circulating combined details of all our events to each other and externally. NWDC has offered the use of its electronic display in their foyer, and the Chippenham Festival's dot matrix will also be brought into use.

It is great to see groups working together, sharing expertise both back-stage and centre-stage, and loaning to each other such things as costume and stage equipment. Practical partnership working.
